To Whom It May Concern:

Thank you for your interest in the Carl Moyer Program and/or the Funding Agricultural Replacement Measures for Emission Reductions (FARMER) Program. The Tehama County Air Pollution Control District (District) is now accepting applications for Year 26 Carl Moyer funding, as well as Year 6 of the FARMER Program funding. The deadline to submit a funding application is **October 31, 2024**. All mailed applications must be postmarked no later than October 31<sup>st</sup>, 2024 to be eligible for funding. You may submit your application to the Tehama County Air Pollution Control District by mail or hand delivery only. Submissions by fax or email will not be accepted.

Projects eligible for funding are agricultural engine projects (i.e. tractors, forklifts, balers, agricultural pumps, etc.) and replacement of agricultural use UTVs with a zero-emission agricultural use UTVs.

Other projects such as on and off-road diesel projects (i.e. filters and/or replacements) and infrastructure (i.e. installation of fueling or energy infrastructure to fuel or power covered sources) may be considered.

Projects will be ranked based on cost-effectiveness and will be funded starting with the most cost-effective to the least cost-effective until available funds are exhausted. UTV replacement projects will be chosen on a first come, first serve basis until all allocated UTV project funds are exhausted.

The submitted application packet must include, at minimum, the following to be considered complete by the District:

- A complete Off-Road/On-Road Equipment Replacement or Repower Electrification Application. The application must be signed by a responsible party.
- A **detailed** quote from your supplier for the new equipment. The quote must include a description and specifications of the proposed new equipment including year, model, horsepower rating, ARB engine Family Number and Executive Order number, a list of included attachments and accessories, price quote, and **warranty information**.
- Proof of ownership — The applicant must have owned the engine for at least two (2) years. Proof of ownership may include bill of sale, title, tax depreciation, maintenance records, general ledger, etc.
- Proof of annual usage — Proof of usage may include hour meter reading log, employee timesheets, repair work orders, preventative maintenance records, fuel purchases, oil changes, etc.
- A Payroll Data Record (PDR) form.


Completeness letters will be mailed within five (5) business days upon receipt of each application. The District may require additional information to process an application. The applicant will have two (2) weeks to submit additional information as requested by the District. If the requested information is not received within two (2) weeks, the District will deny the application and the applicant must reapply to be eligible for funding.
